Except Medary the distance being 44 miles & the
necessary Office is supplied from the South, and that
that there is no route running East & West through
a territory of 27 miles between the Blanchard's fork
of the Auglaize River to the Maumee river whilst
the whole distance is settled for this your
petitioners will ever pray Nov 19th 1847
