

To the Honorable the Congress of the
United States,

The undersigned petitioners,
citizens of the county of Davis State
of Mo. labour under great
inconvenience for the want
of a mail route from Brunswick
in the county of Chariton State
of Mo. via Pittsburg to Galatun
in the Co. of Davis State of
Mo. a distance of about sixty
miles. By the present mail
route our mail is taken
from Keytesville, via Simeas in
the county of Linn, Chillicothe and
Vandalia in the Co. of Livingston
to Galatun, a distance of
nearly one hundred miles,
which makes our mail at
least one week later than the
mail at Brunswick. Whereas,
if we had a mail from
Brunswick via Pittsburg, we
could have the mail in
one and a half or two days.
We therefore pray your Hon-
orable body to establish the
above route, and your petiti-
oners, as in duty bound, will
ever pray.
