susceptible of improvement, they would recommend
that an Act be passed establishing the Postage accor-
ding to the following rates —

First - 2 cents on each letter weighing $\frac{3}{4}$ of an ounce
under 500 miles; 5 cents over 500 & under 1500 miles;
and 10 cents over 1500 miles -

Secondly 1 cent on each Newspaper. Periodicals in proportion
