To prohibit the introduction of slaves into the district of Columbia as merchandise or for sale or hire.

- 1 Be it enacted by the Senate and House of Repre-
- 2 sentatives of the United States of America in Congress
- 3 assembled, That the business of introducing or importing
- 4 slaves into the District of Columbia as merchandise or
- 5 for sale or hire be, and the same is hereby, prohibited.
- 1 Sec. 2. And be it further enacted, That if any per-
- 2 son shall hereafter bring or import any slave or slaves into\_
- 3 the district aforesaid as merchandise, or for the purpose of
- 4 selling or hiring such slave or slaves, or shall be accessory
- 5 thereto, the person or persons so offending shall be deemed
- 6 guilty of a misdemeanor, and, on conviction thereof, shall

- 7 be fined in the sum of five hundred dollars, and be im-
- 8 prisoned a term not less than one nor more than six
- 9 months, at the discretion of the court, for each and every
- 10 slave by him brought into the district aforesaid as mer-
- 11 chandise or for sale or hire.
